

AMENDMENT NO. 1
TO AGREEMENT FOR
LEGAL CASE MANAGEMENT SYSTEM SOFTWARE SOLUTION
BETWEEN

WHEREAS, the State of Florida, Department of Legal Affairs, Office of the Attorney General, (OAG), and Legal Files Software, Inc., (CONTRACTOR), as the parties to this Contract have agreed to an amendment of Contract No. K04387, and

WHEREAS, the parties have agreed that since the OAG no longer desires to purchase the Legal Files Portal Mode Licenses Module Package (includes 150 portal mode licenses) as part of the Legal Case Management Software Solution proposed by the CONTRACTOR, and

WHEREAS, the Agreement must be modified to delete the requirement for the CONTRACTOR to deliver, maintain and support said Legal Files Portal Mode Licenses Module Package, as described in **ARTICLE 3, SCOPE OF SERVICES**, and **ARTICLE 4, COMPENSATION**;

THEREFORE, the Parties agree to amend the Agreement as follows:

- 1) **ARTICLE 3**, of the Agreement, entitled **SCOPE OF SERVICES**, is modified to reflect the present intent of the parties by the deletion of the Legal Files Portal Mode Licenses Module Package from the Legal Files Legal Case Management System software solution, as well as from the deliverables set forth later in that **ARTICLE**.
- 2) **ARTICLE 4** of the Agreement, entitled **COMPENSATION**, is hereby amended to delete the Legal Files Portal Mode License Package as an element of the Year One Costs during the initial term of the Agreement, and the Total Cost of \$19,755 for said Portal Mode License

Package, already paid to the CONTRACTOR, will be forthwith returned to the OAG through an appropriate credit to be applied to any selected invoices as chosen by the OAG upon execution of this Amendment to the Agreement as set forth in Paragraph 3 below.

3) Because the Legal Files Portal Mode Licenses Module Package, including the 150 portal mode licenses, was part of Deliverable No. 1, due for delivery on or before April 27, 2018 pursuant to **ARTICLE 3** of the Agreement, the Module Package has already been delivered and the CONTRACTOR has already received the Total Cost of \$19,755. Upon execution of Amendment No. 1, the CONTRACTOR shall credit the OAG with \$19,755 on any invoice for payment submitted by the CONTRACTOR pursuant to **ARTICLE 5, INVOICING**, as selected by the OAG per a request to do so in writing. Email correspondence sent to the CONTRACTOR's contract manager by the OAG contract manager, the Director of Administration, or his/her designee, shall constitute a request in writing to apply the credit to a particular invoice. The selected, itemized invoice shall clearly indicate that the \$19,755 has been credited to the invoice pursuant to the terms of Amendment No. 1, showing a net reduction of \$19,755 in the overall billing represented by the selected, itemized invoice.

IN WITNESS WHEREOF, the State of Florida, Department of Legal Affairs, Office of the Attorney General, and Legal Files Software, Inc., have executed Amendment No. 1 to Contract No. K04387.
