[REDACTED] can be viewed wearing purple Minecraft underwear captured with his exposed buttocks and lying in a bed, video depicts [REDACTED] naked on a bed as Nathan Holmberg directs the child in a playful manner to get his genitals after [REDACTED] touches the defendant's genitals the defendant directs the child to get his sexual organ without hands, leading to the defendant's sexual organ penetrating the mouth of [REDACTED] knowing the character and content thereof, which included sexual conduct by a child less than 18 years of age, in violation of Florida Statute 827.071(3).

The photographs focus on the genitals of [REDACTED] while he is laying on a bed naked., knowing the character and content thereof, which included sexual conduct by a child less than 18 years of age, in violation of Florida Statute 827.071(3).

COUNT XVII: PROMOTING A SEXUAL PERFORMANCE BY A CHILD (F2)

NATHAN DOUGLAS HOLMBERG On or between December 27, 2024 and October 20, 2025, did unlawfully produce, direct or promote a sexual performance, to-wit: Nathan Holmberg produced and/or directed a compilation of video and photographs exhibiting and/or depicting a child [REDACTED] in a sexual performance. [REDACTED] is viewed wearing a black shirt with a turkey on it holding video game controller displaying his exposed sexual organ and with his underpants held down below his penis, Nathan Holmberg is viewed pulling the clothing of [REDACTED] off, this compilation includes video of Nathan Holmberg masturbating the sexual organ of [REDACTED] with his hand, as well as causing [REDACTED] to masturbate the defendants penis and causing the sexual organ of [REDACTED] to penetrate the mouth of the defendant. A blue and white Pineapple blanket is displayed in the video, knowing the character and content thereof, which included sexual conduct by a child less than 18 years of age, in violation of Florida Statute 827.071(3).

COUNT XVIII: PROMOTING A SEXUAL PERFORMANCE BY A CHILD (F2)

NATHAN DOUGLAS HOLMBERG On or between December 27, 2024 and October 20, 2025, did unlawfully produce, direct or promote a sexual performance, to-wit: Nathan Holmberg produced and/or directed a compilation of video and photographs exhibiting and/or depicting a child [REDACTED] in a sexual performance. The compilation exhibits photographs showing the hand of [REDACTED] on Nathan Holmberg's sexual organ while Nathan Holmberg's sexual organ is coming in contact with the face of [REDACTED] exhibits video showing [REDACTED] in a bed while the defendant can be seen penetrating the mouth of [REDACTED] with his sexual organ, video of [REDACTED] is viewed laying down on a bed with the defendant above [REDACTED] as the defendant touches the face of [REDACTED] with his sexual organ., knowing the character and content thereof, which included sexual conduct by a child less than 18 years of age, in violation of Florida Statute 827.071(3).

COUNT XIX: PROMOTING A SEXUAL PERFORMANCE BY A CHILD (F2)

Photographs show a child [REDACTED] wearing Jurassic park underwear with a progression of clothing removal, in video showing [REDACTED] naked in a bed pulling Nathan Holmberg pants off exposing the defendants sexual organ, the defendants underwear can be seen as gray with a blue top, knowing the character and content thereof, which included sexual conduct by a child less than 18 years of age, in violation of Florida Statute 827.071(3).

COUNT XX: PROMOTING A SEXUAL PERFORMANCE BY A CHILD (F2)

NATHAN DOUGLAS HOLMBERG On or between December 27, 2024 and October 20, 2025, did unlawfully produce, direct or promote a sexual performance, to-wit: Nathan Holmberg produced and/or directed a compilation of video and photographs exhibiting and/or depicting a child [REDACTED] in a sexual performance. Video shows [REDACTED] naked in a bed with wet hair and [REDACTED] can be seen with the sexual organ of Nathan Holmberg penetrating the mouth of [REDACTED], the defendant is engaging in enticing [REDACTED] to catch the defendants sexual organ and instructing [REDACTED] puts his mouth on the defendants sexual organ and spits, knowing the character and content thereof, which included sexual conduct by a child less than 18 years of age, in violation of Florida Statute 827.071(3).

COUNT XXI: PROMOTING A SEXUAL PERFORMANCE BY A CHILD (F2)

[REDACTED] is wearing red pants and a blue fox blanket is on his torso, knowing the character and content thereof, which included sexual conduct by a child less than 18 years of age, in violation of Florida Statute 827.071(3).

COUNT XXII: PROMOTING A SEXUAL PERFORMANCE BY A CHILD (F2)

NATHAN DOUGLAS HOLMBERG On or between December 27, 2024 and October 20, 2025, did unlawfully produce, direct or promote a sexual performance, to-wit: Nathan Holmberg produced and/or directed a compilation of photographs and videos exhibiting and/or depicting a child [REDACTED] in a sexual performance. [REDACTED] can be viewed in photographs with red Pokemon pants, photographs show a progression of the pants of [REDACTED] as they are pulled down exposing the sexual organ of [REDACTED] and until [REDACTED] is naked. Video is showing [REDACTED] laying down touching his genitals with his hand while watching children's show, several toys can be seen on the floor including a stuffed snoopy and Pokemon, [REDACTED] is seen in black pants exposing the sexual organ, the Pokemon pants can be seen on the floor., knowing the character and content thereof, which included sexual conduct by a child less than 18 years of age, in violation of Florida Statute 827.071(3).

Children's underwear displaying cars can be seen in the photographs., knowing the character and content thereof, which included sexual conduct by a child less than 18 years of age, in violation of Florida Statute 827.071(3).

COUNT XXIV: PROMOTING A SEXUAL PERFORMANCE BY A CHILD (F2)

NATHAN DOUGLAS HOLMBERG On or between December 27, 2024 and October 20, 2025, did unlawfully produce, direct or promote a sexual performance, to-wit: Nathan Holmberg produced and/or directed a compilation of video and photographs exhibiting and/or depicting a child [REDACTED] in a sexual performance. The photographs show [REDACTED] naked in a bed with a focus on exposing the anus of [REDACTED] Nathan Holmberg masturbating the penis of [REDACTED] and Nathan Holmberg's finger penetrating the anus of [REDACTED]. Video depicts the defendant rubbing the buttock of [REDACTED] while opening the buttocks of [REDACTED] exposing the anus of [REDACTED], and video depicting defendant masturbating victim's sexual organ with the defendant's hand and the hand of [REDACTED] simultaneously. A pink pillow, a blue blanket and hello kitty pants can be seen on the bed., knowing the character and content thereof, which included sexual conduct by a child less than 18 years of age, in violation of Florida Statute 827.071(3).

[REDACTED] is seen spinning around Nathan Holmberg trying to catch the defendant's erect penis and Nathan Holmberg penetrates the mouth of [REDACTED] with his sexual organ, a video shows the defendant is laying in the bed with an erect penis while [REDACTED] is pulling the defendant's sexual organ out of the defendant's black bottoms, the defendant can be heard enticing [REDACTED] to continue, knowing the character and content thereof, which included sexual conduct by a child less than 18 years of age, in violation of Florida Statute 827.071(3).
