

Crime Stoppers of Sarasota Cty is requesting to transfer \$367.00 from Line 71 General Liability insurance to Line 52 Storage Rent and \$61 from Line 69 Employee Bond Insurance to Line 52 Storage Rent. The organization has found it necessary to obtain a larger storage unit to accomodate all of its capital items, brochures, and promotional items. Sveral of the larger items had been stored at the LEO coordinator's office at the Sarasota County Sheriff's Office. Unfortunately, that storage space is no longer available to the organization. The larger unit's costs will cause the current budget to be depleted prior to the end of the grant year if the additional funds are not transferred to line item #52 Storage Rent.

The organization participates in several community events throughout the year. Shelving in the storage unit, which takes up allot of space, allows Crime Stoppers to efficiently organize its public awareness materials making it easier for the board members to retrieve items for events as well as keep an accurate inventory of all materials so as not to over purchase nor fully deplete supplies. Large items such as the event tent, table and chairs need to stored with the public awareness materials as well for easy access by board members who volunteer for community events.


