We want to move money from line item #33 because we will no longer run "Wanted Ads" with TCPalm Newspapers. This money will be moved to line item #11 (bus wraps).

We want to move money from line item #14 (radio) to line item #11 (bus wraps). Line item #14 (radio) has too much money left in the account that is not used for the radio.

This budget modification will allow us to add three (3) more busses with our advertisement displayed. The bus wrap advertising we instituted in 2015 was resulted in increased tips in county where the busses operate. TCCS is confident additional busses on additional routes will result in more tips.

\$1000.00 from line item #14 (radio) will also go to line item #52 (storage rent). We need to rent a storage unit as well. TCCS was fortunate in the past to be able to store our files, equipment, promotional banners and other items in a storage unit provided at <u>no cost</u> by the Indian River County Sheriff. This unit is now unavailable so TCCS must rent a storage area.

\$1000.00 from line item \$14 (radio) will go to line item #24 (banners) so that we can buy a banner to be used at public events.

Also, \$1000.00 from line item #14 (radio) will go to line item #73 (travel) for travel expenses to be utilized for training employees about Grant requirement in Tallahassee.

The \$1000.00 will be used to rent a storage unit to house our files.
