

CONTRACT AMENDMENT BETWEEN
THE DEPARTMENT OF CORRECTIONS
AND
OFFICE OF THE ATTORNEY GENERAL

This is an Amendment to the Contract between the Florida Department of Corrections ("Department") and Office of the Attorney General ("Agency") to provide for the use of inmate labor in work programs.

This Amendment:

- renews the Contract for one (1) year pursuant to **Section I., B., Contract Renewal**;
- revises the end date of the Contract referenced in **Section I., A., Contract Term**; and
- adds **Section VII., H., Prison Rape Elimination Act**.

Original contract period: February 10, 2014 through February 9, 2015

In accordance with **Section V., CONTRACT MODIFICATIONS**, the following changes are hereby made:

1. **Section I., A., Contract Term**, is hereby revised to read:

A. This Contract began February 10, 2014 and shall end at midnight on February 9, 2016.

This Contract is in its final renewal year.

2. **Section VII., H., Prison Rape Elimination Act (PREA)** is hereby added:

H. Prison Rape Elimination Act (PREA)

The Agency shall report any violations of the Prison Rape Elimination Act (PREA), Federal Rule 28 C.F.R. Part 115 to the Department of Corrections' Contract Manager.
