### VIDEO CONSUMER ALERT: AG Moody Issues Tips for Floridians to Avoid Fraud During National Identity Theft Awareness Week



TALLAHASSEE, Fla.—Attorney General Ashley Moody is issuing a Consumer Alert during National Identity Theft Awareness Week with tips for Floridians to avoid fraud. The [Federal Trade Commission received more than 1.1 million reports nationwide](#) of identity theft in 2022. The FTC also reports that consumers lost nearly \$8.8 billion to fraud in 2022, a 30% increase over the previous year.

**Attorney General Ashley Moody** said, “Identity theft affects millions of Americans every year and can cause extreme hardship for victims. During National Identity Theft Awareness Week, I am issuing tips for Floridians to safeguard their information and avoid fraud.”

Attorney General Moody offers these tips to help Floridians avoid falling victim to identity theft:

- **Exercise Caution Online:** Be cautious when sharing personal information online by ensuring websites are secure and reputable before providing any sensitive data. Create complex passwords and consider using two-factor authentication for added security on online accounts;

- **Secure Personal Information:** Shred documents containing personal details like Social Security numbers and financial information before discarding;
- **Monitor Financial Statements:** Regularly review bank statements, credit card bills and financial accounts for unauthorized transactions or suspicious activities; and
- **Consider Credit-Monitoring Services:** Explore options for credit-monitoring services that can provide alerts for any suspicious activities related to your credit profile.
