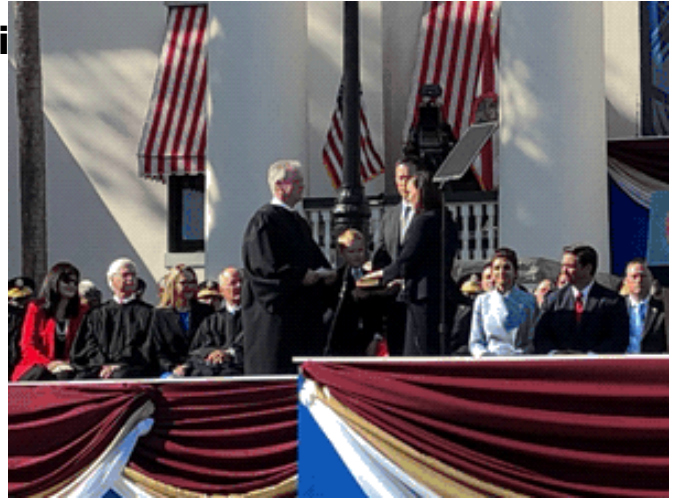


**Date** January 10, 2019

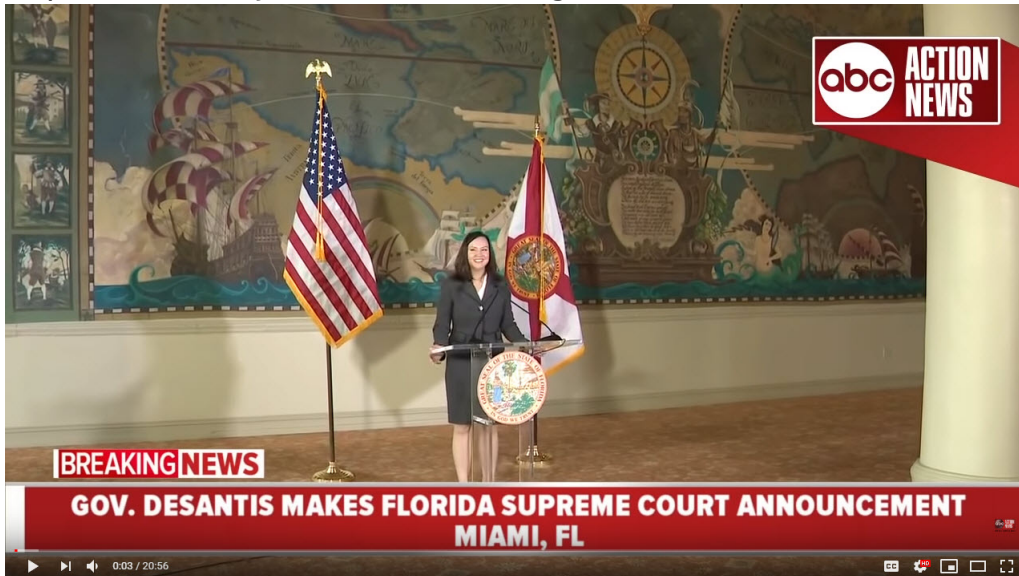
